Statement: Governor Mills' Abortion Agenda

Maine Right to Life is deeply troubled by Governor Mills abortion agenda. Despite her campaign promise to leave current abortion law as it is, it has become abundantly clear that she has been bought and sold by the Pro-Abortion lobby and Planned Parenthood. Her policy on abortion is out of touch with how the general public really feels.

A recent [Marist College poll](#) found that 69% of Americans want abortions banned or limited. Nearly half of all Americans support abortion bans, while 70% of Americans want to ban late term abortions. Since overturning Roe, across the country, support for limiting abortion has increased.
